Bonus Rebates to Support Smoke Damage Repairs

Income Qualified Customers

For income qualified customers, there are additional bonus rebates available for attic insulation up to \$5,000 (regularly \$3,500). This rebate is available to customers in the same four zip codes and will apply to work completed January 1, 2022 to December 31, 2023.

Income qualification must be established prior to work being completed. Once eligibility has been confirmed, the call center will provide the list of approved contractors for the IQ rebates.

^{**}The typical pre-job R-value requirement of less than R-15 is waived for customers within the identified zip codes.

Rebate Requirements

- Eligible zip codes are limited to 80303, 80305, 80020, 80027.
- Improvements must be made between January 1, 2022 to December 31, 2022.
- Application received date deadline is January 31, 2023.
- Because of smoke and ash, existing insulation must be removed.
- Customers should verify that the insulation and air sealing contractor is listed as a participating contractor on Xcel Energy's Trade Partners website. Only participating contractors can offer the insulation and air sealing rebates. https://hvacree.net/xcel-co/public search.cfm
- Air sealing is required if the home is not already tight enough. In smoke damaged homes, remove the existing attic insulation before doing the blower door test.

Invoicing Needs

- Must provide an estimate of existing attic insulation R-value.
- Itemize the cost of insulation removal and disposal (combined). Can be done by a third party instead.
- Itemize the qualifying improvement's combined labor and materials cost for each insulation and air sealing measure.

- CAZ Testing required
- R-49 minimum

Wall Insulation: \$200 (\$100 standalone rebate, \$100 bonus rebate)

- R-19 minimum or fill wall cavity
- CAZ Testing required
